The ONLY indoor facility available is at the primary venue, The Gallery, at Virginia International Raceway. Shelters may be constructed by exhibitors. Indoor restrooms are available at The Gallery, portable restrooms and potable water are available at outdoor exhibits. You must provide your own tables, chairs, tablecloths, booth carpeting/flooring, etc. if needed for your display. Quiet style generators are only allowed for outdoor displays.
2. Exhibitors are responsible for care and maintenance of their display and demo areas before, during, and after the event.
3. The event is open to the attending government/industry participants from 8am-5pm on Tuesday, Wednesday and Thursday and during (Tuesday) night demo hours. During these hours, we ask that you adhere to professional standards to show respect to the attending government representatives.
4. **Exhibitors:** Please specify any special requests and electrical requirements needed. If you have a trailer that must stay on-site, please specify on your Registration Form. Only quiet style generators are allowed at outdoor exhibits.

Early registration is highly encouraged, as space at the event is limited. Late registrations could be excluded from the program. There will be NO WALK-IN Registration.

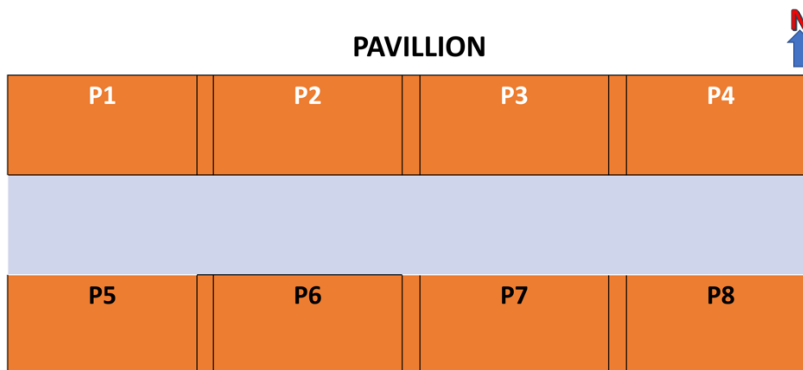
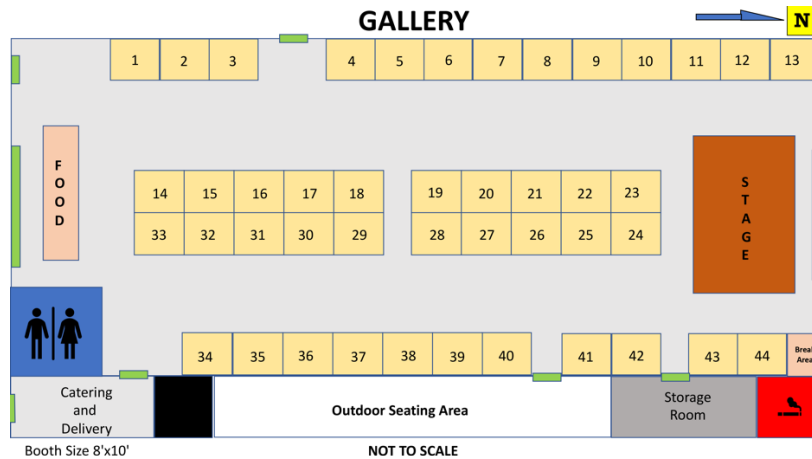

- b. **Automobile Liability Insurance** – Automobile liability in a minimum amount of not less than \$1,000,000 each accident.
- c. **Worker's Compensation Insurance** – Including Employer's Liability coverage, in an amount not less than \$1,000,000.

EXHIBITOR RULES & REGULATIONS

1. ITAR and EAR Regulations: Exhibitor displays are subject to the International Traffic in Arms (ITAR) and the Export Administration Regulations (EAR) and are limited to public domain information (ITAR Sec.120.11). In addition, displays, literature and discussions will NOT reference DOMOPS or Special Operations missions, tasks or units.
2. Registration for Virginia International Raceway (VIR) exhibit space must be accompanied by the required fee in order to guarantee reservation. Exhibit space for which payment has not been received in full will not be allowed onto the VIR site for setup. All payments must be received within 7 days of registration and unpaid reservations will be released for resale after the allotted 7 days.
3. All VIR site exhibits must fit within the confines of their assigned space so as not to impede traffic flow, infringe on the space of other exhibitors, or violate the emergency exit routes set forth by the Virginia International Raceway. No rigid walls are permitted to be built on the perimeter in any island booth spaces without advance permission.
4. Floor/ground covering is required for all VIR site exhibits if the exhibit/demonstration at the allotted space involves potential chemical spillage (corrosives, fuel, oil, etc.) or significant heat exposure. All exhibitors are subject to fire code regulations, which include exhibits that contain flammable combustible substances. If exhibit or demonstration includes significant heat source or open flame (survival cookware as example), exhibitor must have on hand appropriately rated and certified portable fire extinguisher.
5. All exhibitors who display firearms or firearm accessories are required to render the firearms incapable of firing or discharging any cartridge, shell, round or load unless conducting authorized controlled demonstration. A trigger lock or plastic strap limiting the action is not an acceptable method of making a firearm inoperable. Any real or simulated discharge of firearms or non-powder actuated guns accompanied by an audible report is strictly prohibited. During hours when Strike Challenge is not in session, weapons need to be secured.
6. No Exhibitor shall sublet or share the whole or any part of the VIR space contracted to them. Exhibitors agree to limit the materials displayed in their exhibit area to those purveyed by the exhibitor, with the exception that other proprietary equipment may be used solely for the purpose of effectively demonstrating the capabilities of the exhibitor equipment.

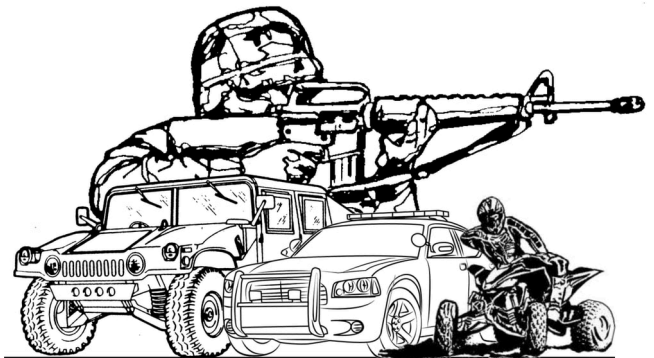
